DIRECTION # 1: FROM MIDDLETOWN

- MHA is located just off 17M, Drive to 17M (which is also known, for parts of it, as Dolson Avenue).
- As soon as you see the signs for "Quick Check" turn left on James P. Kelly Way (former County Highway 108).
- Go about a 1/8 of a mile and on the left side you will see a sign on a parking lot that says AccuCare Pharmacy.
- Turn left into the AccuCare parking lot.
- MHA is located in the same building as AccuCare. MHA's sign is on the building.

FROM NEWBURGH. MONTGOMERY. WALDEN. MAYBROOK, and HAMPTONBURGH

- Take Rt. 84 West to Exit #3W (US-6 West/RT-17M West). Turn right for US-6 West/RT-17M West. **Go to** second light, make a left onto James P. Kelly Way (former County Highway 108) and follow direction #1.

FROM PORT JERVIS. GREENVILLE. MOUNT HOPE. NEW JERSEY and PENNSYLVANIA:

- Take Rt. 84 East to Exit#3W (US-6 West/RT-17M West). Turn right for US-6 West/RT-17M West. Go to second light and make a left onto James P. Kelly Way (former County Highway 108) and follow direction #1

FROM GOSHEN. HARRIMAN. MONROE. KIRYAS JOEL and CHESTER

- Take 17 West. Get off Exit 123 to 17M. Go approximately 6 miles and follow direction #1.

FROM NEW WINDSOR. WASHINGTONVILLE. CORNWALL, and BLOOMING GROVE

- Take **FROM WARWICK. FLORIDA. GREENWOOD LAKE and TUXEDO PARK**
- Take Route 6 North OR 17A North to 17 West. Get off exit 123 to 17M. Go approximately 6 miles and follow direction #1,

FROM SULLIVAN COUNTY. BLOOMINGBURGH and BINGHAMTON:

- Take 17 East to Exit 121(Scranton, Port Jen/is}. Exit 121 will place you on 84 West. Once on 84 West take Exit#3W (US-6 West/RT-17M West). Turn right for US-6 West/RT-17M West. Go to second light; make a left onto James P. Kelly Way (former County Highway 108) and follow direction #1. Route 94 South to 17 West. Get off Exit 123 to 17M. Go approximately 6 miles and follow direction.

#FROM ALBANY. NY

- Take 87 South to RT 17 K Exit 17. Then take 84 West Newburgh/Stewart Airport Exit. Once on 84 West take Exit # 3W (US-6 West/RT-17M West). Turn right for US-6 West/RT-17M West. Go to second light; make a left onto James P. Kelly Way (former County Highway 108) and follow direction #1.
